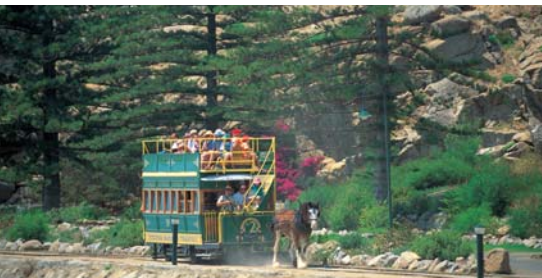

1. **ENQUIRE:** Call HSP Travel to check that your preferred dates are available - we'll make you a Tentative* Booking holding your dates for up to 7 days while arranging your Travel.

2. **TRAVEL:** Make your travel arrangements to coincide with your proposed Arrival & Departure dates. If you require domestic Airline bookings, HSP Travel may be able to arrange.

3. **CONFIRM:** Pay HSP Travel your booking deposit of AU\$200 per person within 7 days to confirm your booking (and pay us the balance within 30 days prior to your Arrival date).

Legal Contract When you make a booking with us legal obligations arise and your right to refund of monies charged to your credit card or paid in any other way agreed by us, are limited by our terms and conditions and by the terms and conditions of the particular third party supplier of products and services. Fares, Booking Confirmations A \$200 security deposit per person, per tour and the balance of any airfares booked by HSP is required at the time of booking. The balance for the holiday package must be paid not less than 30 days before departure. Where connecting air, rail or boat travel is included, you must confirm the correct fare at time of paying the balance. Twin share prices are per person unless otherwise stated. Credit card surcharges apply and will be added to the price of your holiday package. HSP reserves the right to cancel any ticket or booking or to refuse to carry any passenger where payment has not been received by HSP within the specified time.

Airfare Conditions Rules and regulations affect advance purchase and other discounted air fares, including cancellation or amendment fees, in some instances there are no refunds whatsoever on cancelled holidays and/or air tickets should you need to amend or cancel your travel plans. You must refer to the particular supplier of travel services, such as the relevant airline, for their terms and conditions of travel. You must read the terms and conditions applicable to every airfare or other form of travel and ensure that you accept those terms and conditions before you make a booking with us. Once you confirm a booking and make payment you are bound by the terms and conditions applicable to the relevant supplier.

Insurance We strongly recommend that all clients take out travel comprehensive insurance when making a booking. We recommend that insurance covers loss of deposit and other monies through cancellation, loss or damage to personal baggage and loss of money, medical expenses, additional expenses to cover hotel accommodation and repatriation costs. Please note that restrictions on the time to effect insurance apply to some services such as airfares. Please contact us to arrange travel insurance before making payment for a service.

Cancellation and Refund Policy Any notice of cancellation, postponement of your travel arrangements or alteration you make to them must be in writing and received by us to be effective. If effective notice is received by us then the following will apply:

1. No refunds will be made for holiday package inclusions that are not utilised. (Only tours cancelled by the operator due to weather, etc. may be refunded upon receipt of a valid voucher and letter of request, but no guarantee is given by us that the operator will provide a refund).
2. If we receive your cancellation less than 15 days prior to the date of commencement of your holiday, or if you should not depart at all then we will not refund any money paid by you.
3. If we receive your cancellation between 15 to 21 days prior to the date of commencement of your holiday, then we will refund to you 80% of the holiday package cost.
4. If we receive your cancellation more than 21 days prior to the date of commencement of your holiday, then we will refund to you the cost of your holiday package, after deducting \$50 per person administration fee.
5. Postponement of a package may be permitted at Holiday Special Packages' discretion, however, we will charge you an additional \$50 administration fee. If you postpone your holiday and any third party supplier charges additional fees, for example, because they deem that postponement to be a cancellation, then those fees will be passed on to you for payment, in addition to the administration fee charged by us. If you postpone your holiday to a time of different seasonal demand and/or there is an intervening price increase by us or by our third party suppliers, then the cost of your holiday will be increased to meet any price increases due to seasonal charges as well as charges of third party suppliers. Any subsequent cancellation will incur the cancellation fees applicable in accordance with paragraphs 1 to 4 above at the time of the original postponement.
6. Any amendment to a confirmed booking is subject to availability and any cancellation due to amendment will incur the above cancellation fees.

Alterations to Tour Itineraries by Suppliers In the event of material alterations by a supplier to a proposed tour booked by you, you may be given the option of cancelling the tour without penalty but this is not guaranteed. The right to cancel is subject to the conditions of the supplier.

Itineraries Itineraries are subject to alteration without notice and intended as a guide only. We reserve the right to cancel or alter itineraries or bookings where circumstances require, these circumstances include, but are not limited to, situations in which your health or personal safety may be at risk. Alterations may come about due to road, weather or tidal conditions, strikes, public holidays, or other reasons.
